Official Rules
NO PURCHASE NECESSARY.
VOID WHERE PROHIBITED BY LAW.

VIP Preferred (the “Sponsor”) is pleased to introduce the VIP Preferred Drawings, (the “Promotion”), in which invitees will have the chance to win cash* & prizes (as defined in Section i).

As a condition of participating in the Promotion, you agree to be fully and unconditionally bound by these Official Rules and the decisions of Sponsor, whose decisions shall be final and binding in all respects, and to waive any right to claim ambiguity in the Promotion, these Official Rules, Promotion materials and information contained on Sponsor’s websites, (the “Websites”). Winning and receiving a Prize are contingent upon fulfilling all requirements set forth herein.

1. ELIGIBILITY

To be eligible to participate in the Promotion, you must be a legal resident of the United States or Canada, and of legal age within your jurisdiction and invited directly via email from a VIP Preferred participating property to participate (an “Invitee”). Only Invitees may enter. Invitations may not be forwarded or used by any person other than the named Invitee. Any attempt to circumvent this limitation is grounds for disqualification.

Void where prohibited by law. Directors, officers, employees, contractors, agents or representatives of the Sponsor, and each of their respective franchisees, parents, affiliated companies, subsidiaries, distributors, retailers, suppliers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of the Promotion, including, but not limited to VIP Preferred as well as their immediate family and individuals living in the same households, whether related or not, are not eligible to participate in the Promotion. “Immediate family members” shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. “Individuals living in the same household” shall mean those people who share the same residence at least three (3) months a year.

2. HOW TO ENTER

Eligible individuals, as set forth in Section 1, will receive an invitation email from which they may log in to their online account at vippreferredonline.com, and play free games to win drawing entries.

In the event of a dispute as to the identity of any entrant, the authorized account holder of the email address registered with the account used to submit the entry will be deemed to be the entrant. The “authorized account holder” is the natural person assigned the email address by the Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address. Sponsor reserves the right to require entrants to show proof of being the authorized account holder.

Pacific Time shall control for purposes of the Promotion. Sponsor or Sponsor’s designee’s computer shall be the official clock for purposes of the Promotion. Sponsor is not responsible for late or incomplete entries or transmission errors. Sponsor shall not be liable for any problems that occur during the entry process and shall not have any obligation to advise you of an incomplete or undeliverable entry. If a problem occurs in the entry

process, you are solely responsible for verifying that the entry process has been validly completed. Sponsor shall have no obligation to advise an entrant of an incomplete or invalid entry. All entries become the sole and exclusive property of Sponsor and will not be acknowledged or returned. Entrant is responsible for all online charges incurred with any Internet service provider and/or wireless carrier.

3. ENTRY CONDITION AND RELEASE

By entering, you agree to: (i) comply with and be bound by these Official Rules, and (ii) release, indemnify, defend, and hold harmless the Sponsor, and each of its respective franchisees, parents, affiliated companies, subsidiaries, distributors, retailers, suppliers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of the Promotion, including, but not limited to, Engaged Nation Holdings LLC, VIP Preferred, and each of their respective past and present officers, directors, employees, agents, shareholders, contractors, representatives, tribal leaders and council-members (collectively, the "Released Parties") from and against any and all claims, expenses, and liability resulting or arising from the Promotion (including reasonable attorneys' fees), including, but not limited to, negligence and damages of any kind to persons and property, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright, or other intellectual property rights, property damage, or death or personal injury arising out of or relating to your entry, creation of an entry or submission of an entry, participation in the Promotion, acceptance, use, or misuse of a Prize, or the broadcast, exploitation, or use of an entry. 4. HOW THE PROMOTION WORKS

BI-MONTHLY DRAWINGS. The Promotion consists bi-monthly Promotional Drawing Entry Periods. Virtual bi-monthly drawings are held on or about the first business day of the month, from all eligible entries received during the prior two months. Entries earned during the prior two months will be eligible for the Cash* & eGift Card Giveaway (See section 5i.)

Entries for the Cash* & eGift Card Giveaway must be received during the Promotional Entry Period.

SUPER TRIVIA SPECTACULAR.

The Super Trivia Spectacular promotion consists of 30 Super Bowl trivia questions. Each correctly answered question submitted during the entry period will be awarded drawing entries into the Super Trivia Spectacular prize drawing. The virtual drawing will be held on or about February 13, 2024, from all eligible entries received during the promotional entry period. (See section 5i.)

Entries for the Cash* prizes must be received during the Promotional Entry Period.

If for any reason, the Website or Prize Drawing experiences a disruption or malfunction, as determined in Sponsor's sole and absolute discretion, the invitees will be contacted and notified of an alternate drawing at a later time or date nominated by Sponsor.

5. WINNER NOTIFICATION AND VERIFICATION

The winners will be awarded the applicable Prize subject to verification of eligibility and compliance with all terms and conditions of these Official Rules.

Except where prohibited, winners also may be required to sign and return to Sponsor, within three (3) business days from the date when Sponsor's initial verification email was sent, a declaration of eligibility and liability/publicity release ("Declaration") via email to the address specified in the Declaration in order to claim his or her Prize. In such event, Sponsor reserves the right to award the Prizes to the extent

The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

(v) LIMITATIONS OF LIABILITY

To the maximum extent permitted by law, the Released Parties are not responsible for: (i) any incorrect or inaccurate information, whether caused by entrants, technical errors, or by any of the equipment or programming associated with or utilized in the Promotion; (ii) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections of the equipment or software associated with or utilized in the Promotion; (iii) unauthorized human and/or mechanical intervention in any part of the entry process or the Promotion; (iv) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (v) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt, use or misuse of the Prize. Unless otherwise specified in these Official Rules, words importing the singular include the plural and vice versa and words importing gender include all genders. Sponsor is not responsible for any damages caused by delay or failure to perform undertakings pursuant to these Official Rules when the delay or failure is due to weather, event cancellations, fires, strikes, floods, acts of God or the state's enemies, lawful acts of public authorities, delays or defaults caused by common carriers, or other events that cannot reasonably be foreseen or provided against.

(viii) ALTERNATE METHOD OF ENTRY

Participants may hand print their full name, complete mailing address, email address, telephone number and date of birth used to register for a VIP Preferred account, the name of the land-based or iGaming casino associated with their account and the words "VIP Preferred Drawing" on a plain 3" x 5" piece of paper and mailing it, to be received no later than end date of the entry period as defined in the rules.
